## ABOUT COMMUNITY FIRST OXFORDSHIRE

CFO is a community development charity. We help communities and individuals to identify issues that affect them and find their own solutions. We support and advise volunteer-led actions in Oxfordshire, helping hundreds of volunteers fulfil many roles in their communities. We support the principles of Asset-based Community Development. We think that stronger, more sustainable communities are built using the skills and gifts that people already have.

#### **COMMUNITY-LED PLANNING**

CFO is funded by South Oxfordshire District Council to support community groups undertaking a Community-led Plan (CLP). Our team has supported over 100 Oxfordshire communities in carrying out CLP's and related social action projects.

Community Led Planning (CLP) is an inclusive and effective, step by step comprehensive planning tool that is structured to support and empower a community to reflect upon, research, identify and address a range of different social, economic, environmental, and cultural issues. These might include land use, housing issues, community facilities, play areas, transport and services, or responses to COVID-19 related challenges.

The community of South Moreton is currently undertaking a Community-Led Plan.

#### AIMS OF THE COMMUNITY SURVEY

A comprehensive community survey is one of the key means of finding out what residents think about a range of issues.

The survey is an important part of the evidence base underpinning the plan, with the results helping guide the next stage of plan-making, including the discussion of priorities and the drafting of the CLP Action Plan.

CFO, liaising with the CLP Steering Group, prepared the survey questions. CFO analysed the survey returns and produced this report. CFO also created a Survey Monkey version of the survey to facilitate online responses.

#### **DISTRIBUTION AND RESPONSE**

In order to carry out the Community Survey, 130 questionnaires and *Freepost* return envelopes (addressed to CFO) were delivered to South Moreton residences and businesses in December 2020 by volunteers from South Moreton Parish Council and South Moreton Community Led Plan Steering Group.

The survey deadline was 31 January 2021.

61 surveys were returned – 48 online and 13 via hard copy








4. Are you familiar with the following workings of the Parish Council, its responsibilities, and when it meets?




## 5. Which are your preferred ways of finding out about what is happening in and around South Moreton?



7. The Crown has been reopened as a village community pub. How would you rate your experience of your visits to the Crown?









22. How would you rate your mobile phone coverage in your house, your garden and around the village? (1=poor, 5=excellent).







# 24. How would you rate your broadband speed for each of the purposes for which you use it? (1=very slow, 5=very fast).





















#### Note: some of these comments have been edited for brevity and maintaining confidentiality.

- I would support regeneration of recreation ground coupled with limited housing development next to school and parking to be banned outside school and provided for next to school.
- We would rather not see any more houses going up as with Didcot and Wallingford really don't think it's needed.
- There are already many circular walks around the village. There is no point creating new ones if there is no money for maintaining existing ones.
- Move the kissing gate by the railway accessing the field by the stream and out in a concrete slab footbridge across the ditch. Plant more trees and pollinator-friendly shrubs along the recreation area fence line. Create a wildflower area in triangle between footpaths in centre of village.
- Before any more minor, or, major development, further building works commence, there should be an assessment/ upgrade to the sewage / dirty water system in South Moreton as well as the road infrastructure and lack of pavements.... Under capacity and excessive rain fall often results in grey water backing up to properties in Anchor Lane and beyond, as well as spilling out onto the highway at Copse close. The water treatment works is woefully inadequate and often has to employ road tankers or river discharge, to alleviate under capacity.
- Improve and use what South Moreton has already! Maintain and manage the Millennium Wood. Improve and resource the allotments (add water supply) and encourage use. Support The Crown and keep building its offering as a community Hub. Encourage the cessation of noisy fireworks (which terrify dogs, cats, and horses). Promote a supplier of quiet fireworks.
- New or refurbished building are totally inappropriate for this village.
- Speed limit: The new section of High Street and footpath surfaces is a huge improvement... A much more sensible legal limit for the bend would be 20 mph... On school days a 20 mph limit along much of the rest of the High Street would seem to be sensible too. If the High Street was made 20 mph what about beyond that but within the current 30 mph area? There may be a case for transitioning from 30 mph to 20 mph on entering the village and I anticipate that could be accommodated hopefully with minimal additional signage. In the interests of keeping things simple, make it all 20 mph?

<u>Litter</u>: I would be strongly in favour of the continuation/strengthening of any and all measures to keep litter around the village to zero (or at least kept to a minimum where it has occurred inadvertently). Litter seems to be more of an issue alongside the roads into South Moreton.

There is an appalling amount of litter on the right-hand-side of Hithercroft Road going from the village to the Cholsey turn. The ditch along this section has many patches of drink cans, plastic containers, etc. Road-side litter and the results of fly-tipping are surely depressing sights anywhere (not least in our local AONB)....

I'm not sure which organisation has responsibility for clearing the litter and fly-tipping waste from our roadsides, etc, but evidently it is not being done well enough... I recall seeing voluntary litter-picking on the main road through Brightwell-cum-Sotwell and wonder if this is something South Moreton might like to consider for its local roads? However, this would need to be carefully planned and undertaken.


On balance, because it is a common problem (not just around South Moreton), I think it would be best if the appropriate authority undertook clearance of the build-up of rubbish from our roadsides and then kept it to a minimum on at least an annual basis. Or we could just wait for seasonal growth to partially hide the rubbish from sight again. This would be cheaper (at least in the short run) but what signals would it send out to about environment management generally?

- Playground really does need an update. Better landscaping of recreation field more shelter, trees, orchard.
- The school generates huge amounts of traffic and inconsiderate drivers this needs CONTROLLING urgently. The Crown was set up as a community pub and needs to serve the needs of the community....






## 45. Please tell us the age of every member of your household.




## 46. Which of the following best describes you and the members of your household?




47. Do you have any pets in your household?




48. Do you have a disability or a long-term health issue that impacts on your day to day life?
